



How this affects your energy bills

An average household would need to spend £1,847 per year on heating, hot water and lighting in this property. These costs usually make up the majority of your energy bills.

Estimated energy needed in this property is:

- 9,040 kWh per year for heating
- 3,840 kWh per year for hot water
