LOUNGE 14'4 (4.37) into alcove x 14'0 (4.27)

Double glazed window to front, double radiator, fire surround, gas fire, built in storage cupboard, television point, coving to ceiling, laminate flooring.

KITCHEN 6'6 (1.98) x 17'7 (5.36)

Double glazed window to rear, single radiator, range of wall, floor and drawer units with co ordinating roll edge work surfaces, stainless steel sink unit and drainer with mixer tap, tiled splash backs, built in electric fan assisted oven, gas hob with extractor fan above, space for fridge/freezer, plumbed for washing machine/dishwasher, tiling to floor.

Laid mainly to lawn.




