This one-bedroom end of terrace house is situated in a cul-de-sac position in a popular area within the historic town of Alnwick, offering a practical layout and a setting that will appeal to first time buyers and investors alike. The property is in good condition and includes a reception room with access to the garden, a kitchen, double bedroom, and bathroom. Outside, there is the added benefit of parking to the front and a rear garden with side access, providing useful outdoor space. The property may particularly appeal to a buyer who wants a location close to the Willowburn Retail Park and Leisure Centre, as well as Alnwick Town Football Club.

Alnwick's historic town centre is within easy reach, with its range of local amenities including supermarkets, independent shops, cafés and pubs. Alnwick Garden and the grounds of Alnwick Castle offer attractive green spaces, while there are numerous walking and cycling routes in and around the town and out towards the Northumberland countryside and coastline.

Public transport links are available via local bus services connecting Alnwick with surrounding villages, coastal towns and Newcastle. Road access is particularly convenient, with easy access to the A1 for journeys north towards Berwick-upon-Tweed and south towards Morpeth and Newcastle.

The property has an EPC rating of C and falls within Council Tax Band A. It is available for sale with no onward chain.
