COMPOSITE ENTRANCE DOOR:

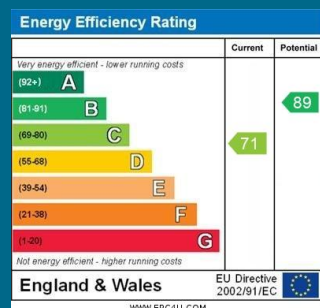
